

Skilib Alpine Club Cooperative Ltd 4WD Car Parking Policy

Purpose:

This policy is intended to provide an operational procedure regarding the allocation of Onsite & Access (Drop-off) 4WD car passes for Skilib members during the winter Mt Buller season.

It also defines the terms & conditions under which Skilib members use any allocated 4WD car pass.

The intent of the policy is to ensure Member applications for a 4WD car pass and subsequent allocation is provided to those with the greatest usage of the club, with consideration to those Members with 2 or more years of membership.

Scope:

This policy applies to shareholders in Skilib Alpine Club and is only relevant to the allocation of 4WD car passes at Skilib Mt Buller.

Policy details:

- 1. Member intentions to apply for a 4WD parking application must be received by Skilib Directors (directors@skilib.com.au) via email, or to Skilib Directors, P.O. Box 140 Canterbury, at least 2 weeks prior to the published application close date, as per the Mt. Buller Mt. Stirling Resort Management Board website.
- 2. Each application must nominate whether the application is for an onsite or access (drop-off) car pass.
- 3. Skilib has 16 rotational vehicle onsite passes available for 8 parking spaces at Skilib Mt Buller.
- 4. Membership of Skilib Alpine Club does not automatically entitle any member to the allocation of a 4WD car parking pass. On-site 4WD parking passes are regarded as a privilege and not a given right as part of being a Member of Skilib Alpine Club.
- 5. It is the responsibility of the member to ensure their intent to apply for a 4WD car pass is received by the club's Directors at least 2 weeks prior to the

- application close date (as advised by the Mt. Buller Mt. Stirling Resort Management Board).
- 6. If you are allocated an access car pass, you do not have parking privileges at Skilib. You must only drop-off luggage and proceed directly to normal access carparks (Tip Corner and lower parks), ensuring that your car is temporarily outside Skilib for no more than 30 minutes.
- 7. Onsite car passes are allocated to a specific individual and are not transferable to other guests / members. This means if you are allocated an onsite pass you cannot loan your car to someone else (apart from your spouse) for the purpose of parking at Skilib.
- 8. If a 4WD on-site pass holder is not staying at Skilib, then they have no rights to park at Skilib. To be clear, if you are staying elsewhere, then you are not permitted to park outside Skilib in one of our allocated parking spaces.
- 9. If there are more than 16 onsite parking applications received for a season then the following process will be used to allocate onsite car passes.
 - a. Director's who have a minimum of 12 personal booking nights for the season at the time of application allocation will have first priority.
 - b. Other members with 2 or more winter seasons as a member of Skilib will be allocated a pass based on their personal booking nights for the season at the time of application allocation, with those having the greatest booking night numbers receiving highest priority.
 - c. Members with less than 2 winter seasons as a member of Skilib will be given priority after the above applicants. Applicants will be allocated a pass based on their personal booking nights for the season at the time of application allocation, with those having the greatest booking night numbers receiving highest priority.
 - d. Only one onsite pass will be granted to a family membership should there be multiple members in the family.
 - e. All applicants will be advised by Skilib Directors of the outcome of their application. Mt Buller Mt Stirling Resort Management Board will subsequently advise formal notification to successful applicants.
 - f. For those applicants that were unsuccessful with an onsite parking request, an access (drop-off) pass will be allocated.
 - g. Applications for an access pass will be automatically approved by Directors.

- h. Where the last remaining on-site parking allocation is between more than 1 shareholder, with those shareholders having the same personal booking night numbers, then the Directors will conduct an impartial blind draw to determine the successful applicant, pursuant to clauses 9b and 9c.
- i. For all other situations where this procedure is silent, the Directors will determine and advise the relevant decision or outcome.

Usage

- 1. Skilib is restricted in only having 8 onsite car parking spaces.
- If you arrive at Skilib and all 8 car parking spaces are occupied, you <u>must</u> only drop-off luggage and/or passengers and proceed directly to normal drop-off carparks (Tip Corner and lower parks).
- 3. Where there are more than 8 members booked in on any date (usually weekends), the Booking Office will advise such members during the prior midweek period and request a volunteer(s) to park down in the car parks. This request process relies on the goodwill of members and avoids prescriptive measures to manage on-site car parking.
- 4. 4WD car parking at Skilib during the winter season is a privilege. When granted an onsite pass, you can only park in an available Skilib parking space during the time you are booked in <u>and</u> staying at the Skilib Mt. Buller lodge. If you are not staying at Skilib then you **must not** park in a parking space at Skilib.
- 5. Failure to follow the above points will have negative consequences for all car parking applicants and Skilib, including the potential of fines to all parked cars, and/or the reduction or removal of car parking privileges for Skilib.
- 6. If a 4WD pass holder (either onsite or access) does not follow the requirements of this policy, Skilib Directors will advise the Mt. Buller Mt. Stirling Resort Management Board to cancel the car parking pass for the Member in question, and all future onsite parking applications for the shareholder will **not** be granted.
